WAYNE COUNTY COURTHOUSE CLOSED TO PUBLIC

EFFECTIVE WEDNESDAY, MARCH 18

In an effort to address health and safety concerns regarding the Covid-19 and The Proclamation of Disaster Emergency signed by Governor Reynolds on March 17th, the Wayne County Courthouse will be closed until further notice to the public effective Wednesday, March 18 with the exception of the second floor, court systems. Offices and employees will continue to work in the courthouse to conduct business as usual by phone, mail and email. Please help us spread the word to those not on social media and beyond to help eliminate any unnecessary trips to the courthouse. Please be aware these conditions may change abruptly at any time and we will do our best to keep the residents informed.

Any person with COVID-19 symptoms should refrain from entering a public building. At this time, self-monitoring is required by the public and employees. Stay home if you are ill.

Social distancing measures such as increasing the space between workers and the public and decreasing social contacts in the workplace are in place. The recommendation is 6 feet apart and gatherings of 10 or less. Hand shaking is prohibited. Everyone should wash hands thoroughly before entering county facilities and throughout the day. Hand sanitizers will be available at the entrance of the courthouse and in all offices. Office/workspace areas will be cleaned at least daily.

Individuals should consider contacting county offices/departments or conducting business online if possible before visiting any facility. At this time, please contact specific offices.
