Wayne County Board of Supervisors

Regular Scheduled Meeting of the Wayne County Board of Supervisors was held on the 22nd day of February 2022, in the Conference Room of the Wayne County Courthouse, Corydon, Iowa, pursuant to notice duly given in compliance with Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present were David Dotts, Tom Swearingin, Don Seams members of the Board, David Kauzlarich, Scott T Jackson, Bob Jackson, Shelley Bickel, Randy Zerr, Dan Carpenter, Joella Perry, Mendy Middlebrook, Rhonda Bennett, Jen Reed and Michelle Dooley.

The Corydon Times Republican live streams the Board of Supervisors regular session meetings on their Facebook page. **Unless otherwise noted, all motions are approved unanimously by all Board members present.**

Dotts called the meeting to order at 9:06 AM and took roll call.

Pledge of Allegiance

Swearingin made motion to approve the February 22, 2022, agenda with the removal of item# 11 John Sobek IP Pathways & #14 Rhonda Bennett -Wayne County Public Health, seconded by Seams.

Seams made motion to approve the February 7 & 11, 2022, minutes, seconded by Swearingin. Seams made motion to approve the February 18, 2022, payroll, seconded by Swearingin. Swearingin made a motion to approve the February 22,2022, claims, seconded by Seams. No public comments regarding agenda items.

Randy Zerr, County Engineer informed the Board of Supervisors that the flooring for Medicine Creek structure was poured, and that the contractor is working on the walls. Zerr also reminded everyone that the bridge on Birch Road is scheduled to be let this year. Zerr also mentioned that he had emailed the Board the IDOT Budget and the 5-year plan and if there were no adjustments, he would bring the final copy to the next board meeting to be signed off by himself, David Dotts and Michelle Dooley.

Swearingin made a motion to begin the Public Hearing for vacating part of 220th Road at 9:10 AM, seconded by Seams. Bob Jackson, Scott T Jackson & David Kauzlarich were present to speak in favor of vacating part of 220th Road. No one was present to object to the vacation and no written objections were filed. Seams made a motion to approve vacating 220th Road. Seams then realized that the public hearing needed to be closed and he rescind his motion. Swearingin made a motion to close the public hearing at 9:35AM, seconded by Seams.

Dotts read Resolution 22-28 to vacate a county road.

WHEREAS, A public hearing was conducted on February 22, 2022 following publication and service of notice as required by law on the proposed vacation and closure of a portion of Wayne County Secondary Road, described as follows:

Road No. 24

Commencing at the south quarter corner of the northeast quarter of the southwest quarter of Section 15, Township 69 North, Range 20 West, thence north 2061.05 feet, more or less, to the property line of the United States of America.

The aforementioned description was retyped from the Supervisors' Minute Book Number 14, Page 183 (dated December 20, 1993). To the best of the County's knowledge and belief, the road right-of-way width of 220th Street is 66 feet. See attached Exhibit 'A' for road vacation location.

WHEREAS, No objections have been received, either in writing or by persons present.

NOW THEREFORE BE IT RESOLVED by the Wayne County Board of Supervisors that the subject section of road be ordered vacated and closed.

Road No. 24

Commencing at the south quarter corner of the northeast quarter of the southwest quarter of Section 15, Township 69 North, Range 20 West, thence north 2061.05 feet, more or less, to the property line of the United States of America.

The aforementioned description was retyped from the Supervisors' Minute Book Number 14, Page 183 (dated December 20, 1993). To the best of the County's knowledge and belief, the road right-of-way width of 220th Street is 66 feet. See attached Exhibit 'A' for road vacation location.

WHEREAS, Objections have been received by persons present regarding lack of access to their properties, if this entire segment is vacated.

NOW THEREFORE BE IT RESOLVED by the Wayne County Board of Supervisors that the section of this road from the south quarter corner of the northeast quarter of the southwest quarter of Section 15, Township 69 North, Range 20 West, thence north 2061.05 feet, more or less, to the property line of the United States of America be ordered vacated and closed.

Seams made a motion to approve Resolution 22-28, seconded by Swearingin.

Per the request of Randy Zerr, Wayne County Engineer the Board of Supervisors, Dan Carpenter, himself and Auditor Dooley went into a closed session per code section 21.5(i) at 9:40AM.

At 10:20AM, Swearingin made motion to come out of closed session, seconded by Seams.

Dotts stated that there were no decisions to be made and all parties were reviewing and gathering more information regarding the engineer's contract and evaluation and that it would be revisited during the March 7th meeting.

Joella Perry, Veteran Affairs Director reported that Terry Snow is ready to resume his position as VA Commissioner and requested for Dotts to be removed and Snow to be reinstated. Seams made a motion to remove Dotts from his duties as commissioner and reinstated Terry Snow, seconded by Swearingin. Dotts abstained from voting.

Mendy Middlebrook, Mental Health Coordinator presented the 5th revised 28E agreement between the county and CROSS Region. Seams made the motion to approve the revised 28E agreement, seconded by Swearingin.

Also Seams made the motion to approve the Memorandum of Understanding for Reimbursement from the CROSS Region back to the county, seconded by Swearingin.

Seams made a motion to approve deleting the 2014 Dodge Grand Caravan SE and 2009 Chrysler Town & Country from the Capital Asset listing, seconded by Swearingin.

Seams made motion to approve adding the 2022 Trail King Low Boy Trailer (#66) to the Capital Asset Listing, seconded by Swearingin.

Swearingin made a motion to go into closed session per code section 21.5(j) at 10:35AM, seconded by Seams.

Seams made a motion to come out of closed session at 10:56AM, seconded by Seams.

Dotts stated that once the transaction is complete that the recording and minutes will be available for public review.

Seams made motion to go back into open session, seconded by Swearingin.

Seams made a motion to approve the Sheriff's January Report, seconded by Swearingin.

Seams made a motion to approve the Clerk of Court January Report, seconded by Swearingin.
