Wayne County Board of Supervisors

Regular Scheduled Meeting of the Wayne County Board of Supervisors was held on the 14th day of October 2022, in the Conference Room of the Wayne County Courthouse, Corydon, Iowa, pursuant to notice duly given in compliance with Iowa Code Section 21.4. The Board noted due notice of meeting subject to said Code Section.

Present were David Dotts, Tom Swearingin, Don Seams; members of the Board, Lance Lange, Dan Carpenter, Mark McClain, Tyler Sponsler, David Sulser, Jay Terrell, Randy Clark, Jeremy Dooley, Jon Trower, Jesse Woollis, Eric Heston, Roy Benda, James McIntosh, Charles Henderson, Hunter Clark, Brett Draper, Ken Brown Jr, Joella Perry, Hubert Staggs, Jim Fetters(By Phone), Jack Reed, Halie Spidle, Nicole Moore, Bill Byrns, Ericka Graves, and Michelle Dooley.

The Corydon Times Republican live streams the Board of Supervisors regular session meetings on their Facebook page. Unless otherwise noted, all motions are approved unanimously by all Board members present.

Dotts called the meeting to order at 9:00AM and took roll call.

Pledge of Allegiance

Swearingin made a motion to approve the October 14, 2022, agenda with two (2) additional items added after number 18: Administrative Recount Request for Absentee Precinct and swearing in newly elected Treasurer, Amanda Cooper, seconded by Seams.

Seams made a motion to approve the October 31, 2022, minutes, seconded by Swearingin.

Swearingin made a motion to approve the November 10, 2022, Payroll, seconded by Seams.

Seams made a motion to approve the November 14, 2022, claims set, seconded by Swearingin.

No public comments regarding agenda items.

Randy Clark requested the City of Millerton and Wayne County to consider selling a 23'x 100' portion of each Parcel 03200A158002 & 032000A158003 to he and his wife, Barbara. They currently own the lot with a building to the south. Each lot is a 23'x150' parcel and runs east-west off of Main Street and are adjacent to a property the Clark's already own. Clark suggested that the City/County would retain 23'x50' of each parcel for parking the Secondary Road Grader on. Millerton Mayor, Jim Fetters joined the meeting by phone and was not opposed to selling the Clark's the east portion of the lots but wanted to make sure that the road grader would remain in the City of Millerton when not in operation. Swearingin made a motion to proceed with the clarifying the details of the sale, seconded by Seams.

Fetters stated the City Council of Millerton would discuss further at the next regular city council meeting.

Jack Reed drafted a Memorandum of Understanding (MOU) between Wayne County Board of Supervisors and the Secondary Road Employees to be considered as a replacement of the Union Contract effective immediately since the contract is now null and void.

The MOU is not a contract nor is it legally binding and may be reviewed and changed by the Supervisors at any given time. The MOU does allow for many of the current employee benefits to stay in place moving forward with the exception of secondary road employees being allowed to file a grievance against the county and the use of seniority.

Seams made a motion to approve the memorandum of understanding, seconded by Swearingin.

The Secondary Road Department employees were present to discuss the decertification of the union.

They were represented by Mark McClain as their spokesman. McClain discussed the poor representation given by the union during negotiations for the past several years. He discussed how the wages were not keeping up the economic times and requested their salaries to be reviewed and a 15% increase be considered. Seams discussed the need for a section in the handbook specifically for Secondary Road employees which needs to address the shortcomings of the old union contract. It should encourage workers to take more responsibility and be more productive by providing opportunities for advancement. Seams also stated he felt the new board ought to address this.

There was also discussion about job positions/classifications and longevity pay needing to be reviewed and improved upon.

Swearingin made a motion to table the salary decision until the next regular meeting, seconded by Dotts.

Seams voted nay on the action.

Assistant to Engineer, Dan Carpenter reported that awarding the contract for the PCC overlay on J-46 was completed. No conversation with the contractor has taken place regarding start date of the project. The remainder of the reinforcing steel for the Sunny Slope Bridge project as arrived. The contractor for the bridge on Birch Road is expected to close the road today, but they should be able to continue working despite the cold temperatures. The bridge on 180th between Birch and Cedar should be finished this week. They are still running the re-claimer over the highway shoulders and hopefully that will get them through the winter. Patching has been completed. Chris Grimes started employment today and Jeffrey Tuttle will begin November 21st.

Seams made a motion at 10:19AM to go into close session per code section 21.5(1i) to discuss an employee issue, seconded by Swearingin. Jack Reed asked if Lance Lange could be allowed to sit in on the closed session since he would be a part of the discussion in the future. The board agreed. Seams made a motion at 10:34AM to come out of closed session, seconded by Swearingin. Swearingin made a motion to allow Jack Reed and Halie Spidle, New Venture Director to continue to work through resolving an employee issue, seconded by Seams.

Joella Perry, Veteran Affairs Director and Huber Staggs were present to follow up on their request to amend the VA's FY23 Budget for \$31,008.52. Swearingin made a motion to approve the FY23 Budget Amendment, seconded by Seams. This amendment will allow Perry the funding to increase her work week to 40 hours and to hire a part time staff.

Perry will begin advertising for the position and hopefully the position will be filled by January 1, 2023.

Mayor of Allerton, Bill Byrns was present to request an abatement for past, present and future taxes, penalties, interest and fees for parcel 10100D237014 & 10100D237015. Currently the Corydon State Bank holds title to these properties but is willing to deed over to the city if the abatement can be approved. Seams made a motion to table until the properties are deeded over to the City of Allerton, seconded by Swearingin.

Seams made a motion to approve the City of Humeston's request for abatement of current taxes, interest and future taxes for parcel 01150E312005 & 01150F331003, seconded by Swearingin.

Swearingin made a motion to accept and approve the Hazard Mitigation Plan Update Amendment #2, seconded by Seams.

This amendment specifies that the reimbursement will be Federally funded 90% and county funded 10%. This Hazard mitigation Plan will be good for the next 5 years.

Seams accepted and approved the Clerk of Court October 2022 Report, deposits were \$770.07, seconded by Swearingin. Seams accepted and approved the Recorder's Quarterly Report, deposits were \$19,256.53, seconded by Swearingin. Seams accepted and approved the Recorder's October Report, deposits were \$6,007.36, seconded by Swearingin. Seams accepted and approved the Sheriff's October Report, deposits were \$20,179.38, seconded by Swearingin. Seams accepted and approved the Public Health October Report, deposits were \$31,153.16, seconded by Swearingin.

Seams approved Auditor Dooley's request for the County Canvass for the 2022 General Election be rescheduled to Tuesday, November 15, 2022 @ 3PM, seconded by Swearingin.

Swearingin approved Auditor Dooley's request for an Administrative Recount of the Absentee Precinct because of a ballot jamming and being counted twice by the tabulator machine, seconded by Seams.

Swearingin made a motion to table the swearing in of the newly elected Treasurer, Amanda Cooper until after the County Canvass has been completed, seconded by Seams.
