CITY OF CORYDON AND WAYNE COUNTY SUMMARY OF COURTHOUSE MAINTENANCE RESPONSIBILITIES As of November 2022

City of Corydon

- 1. Parking lots on South and West side of courtyard snow removal with any measurable snowfall. City will de-ice/sand parking lots
- 2. East and West Sidewalk(s): snow removal of any depth
- 3. Benches: city replaces when necessary; county maintains
- 4. Picnic tables: city replaces when necessary; county maintains
- 5. Streetlights: city maintains/replaces streetlights around the square
- 6. Parking lot lights: County provides and replaces bulbs; city replaces when necessary.
- 7. Flag poles on street corners: County provides and replaces flags; city replace poles when necessary. Spring 2023 city will work with Aaron to replace ropes.
- 8. Trash receptacles: county empties; city replaces when necessary; city will move three more trash receptables to the courtyard.
- 9. Water hydrants city maintains; county pays for water used at courthouse

Wayne County

- 1. Exterior building maintenance
- 2. Building downspouts
- 3. Lawn care
- 4. Two flag poles directly west of building
- 5. Elevator sump pit
- 6. North and South Sidewalk(s) snow removal
- 7. Wayne County Soldiers of Three Wars Statue county maintains yard around statue.
- 8. Sidewalk(s) deicing

Joint

- 1. Pedestal and pole mounted lights city maintains poles and repairs county replaces lights and globes
- 2. Placement of new benches to be determined by both city/county. Total number to be determined.
- 3. Placement of new picnic tables to be determined by both city/county
- 4. Decorative planters work with local clubs/chamber for future new planters.
- 5. Electrical outlets that service the west parking lot. Outlets by the south parking area paid by Old Settlers Committee
- 6. Trees (trimming and removal of dead standing): county maintains lower branch trimming; city tops trees and removes dead standing trees.

Notes

- 1. Electrical power for the bandstand is supplied by and paid for by Wayne County. The breaker for the bandstand is located in the courthouse basement maintenance room. City owns and provides insurance for bandstand.
- 2. Electrical power for the 4, 1-gang outlets west of the courthouse are supplied by and paid for by Wayne County.
- 3. Electrical power bank south of the south courthouse parking lot is supplied by and paid for by the Old Settler Committee.
- 4. Electrical power bank east of the west courthouse parking lot is supplied by and paid for by Wayne County.
- 5. The Freedom Rock Committee is responsible for all maintenance of the Freedom Rock. Said committee as of 2022 is comprised of Angie Parham, Sharon Anderson, and Wayne Kuhns.
- 6. Events on the square city hall will notify courthouse maintenance directly with information.
